Formation of the EUnited Environmental Committee

EUnited is pleased to announce the formation of its first horizontal Environmental Committee for manufacturers of indoor cleaning and municipal equipment products

On 28 March 2023, EUnited held its first horizontal Environmental Committee meeting online with members from our Cleaning and Municipal Equipment sectors. The committee has already been active in the EUnited Cleaning Sector for several years. However, as environmental legislation becomes increasingly important for the businesses of member companies in other EUnited sectors, a more cross-sectoral approach to dealing with environmental issues is necessary. Consequently, EUnited has transformed the pre-existing Cleaning sector focused Environmental Committee into a horizontal committee for members across all sectors of the association. The topics and files of focus for the committee will include but not be limited to Chemicals (REACH and ROHS), Waste (WEEE, WFD and PPWD), Green claims and European Critical Raw Materials.

The newly formed committee will be chaired by Mr. Steve George, Regulatory Affairs and Sustainability Manager at Numatic International Ltd. Mr. George has participated in the Environmental Committee already for a number of years and has expertise in environmental matters.

Klaus-Dieter Axt, Executive Director EUnited said:

"I believe that the transformation of the Environmental Committee into a horizontal project will most certainly provide added value for our members. The new structure of the committee will enable manufacturers of indoor cleaning and municipal equipment products to develop strong joint positions on key environmental topics for our industries, thereby providing expert input and recommendations to European legislators and regulators."
